Terms

National and international laws that apply to companies whose customers can deposit and withdraw funds from their accounts prevent Nova Premium Finance LTD, its employees or agents from knowingly engaging or attempting to engage in money transactions involving criminal property.

PROCEDURES IMPLEMENTED

The aim of the anti-money laundering procedures that Nova Premium Finance LTD implements is to ensure that customers engaging in certain activities are identified to a reasonable standard, while minimizing the compliance burden and impact on legitimate customers. For this purpose, Nova Premium Finance LTD has developed a highly advanced electronic system. This system documents and verifies customer identification records, and tracks and maintains detailed records of all transactions. Nova Premium Finance LTD closely monitors suspicious and significant transaction activity and reports such activity by "providing full and timely information" to law enforcement. In order to maintain the integrity of corporate reporting systems and safeguards, the legal framework provides legal protection to the providers of such information. AML Policy does not accept cash deposits or withdraw cash under any circumstances. Nova Premium Finance LTD reserves the right to refuse a transfer at any stage if it believes that the transfer is in any way related to money laundering or criminal activity. Nova Premium Finance LTD has no right to inform customers that they have been reported for suspicious activity.
